Graduate standing or permission by instructor.

## Course Description

Weekly graduate seminar on current and emerging topics in food safety. Presentations from OSU faculty and invited external experts from industry, academia, and government. The course is designed to expose graduate students to the wide range of topics and expertise needed to address food safety. Students will learn the role of the public sector in ensuring food safety, including international, federal, state, and local government actors. Students will also learn the role of the private sector in ensuring food safety, including growers, producers, distributors, transporters, retail (including food service), and consumers. Students may enroll in the course more than once. Successful completion of the seminar course is expected to provide the student with an appreciation of: (1) Food safety as a critical public health issue; (2) The role of the public and private sectors in ensuring food safety; and (3) Current topics and research in food safety.

## Goals

By the end of this course, students should successfully be able to:

- 1. Recognize the components of and the role of different stakeholders in the food safety system.*
- 2. Identify current challenges and new research findings in food safety*
- 3. Understand how research contributes to the ability to address food safety concerns*
- 4. Understand the critical role that high quality data plays in being able to effectively address food safety issues*

## How This Online Course Works

**Mode of delivery:** This course is 100% online and synchronous. You must be able to log on to Carmen to access the Zoom link to participate in this class.

**Pace of online activities:** This course covers seven topic areas with each topic taking 2 weeks. The first class for each topic is a lecture from an instructor or a guest lecturer on the topic. Materials may be provided with background information that students are expected to review in advance. The second week for each topic is a discussion session. Students are expected to read assigned materials before class and be prepared to discuss. Each student will be assigned as lead discussant for at least one topic and should be prepared to lead the discussion. Guidance will be provided about how to prepare for leading the discussion session.

**Credit hours and work expectations:** This is a **1-credit-hour course**. According to [Ohio State policy](#), students should expect around 1 hour per week of time spent on direct instruction (instructor content and Carmen activities, for example) in addition to 2 hours of homework (reading and assignment preparation, for example) for this class.

**Attendance and participation requirements:** Research shows regular participation is one of the highest predictors of success. With that in mind, I have the following expectations for everyone's participation:

- **Participating in online activities for attendance: at least once per week**

You are expected to log in to the course in Carmen every week. During most weeks you will probably log in many times. In case of emergency, illness, or other excused reason, please email [Dr. Kowalczyk](#).

- **Extended absences**

If you have a situation that might cause you to miss an entire week of class, discuss it with Dr. Kowalczyk as soon as possible.

- **Zoom meetings and office hours: optional**

All live, scheduled events for the course, including my office hours, are optional. I will post recordings of synchronous sessions for those who cannot attend.

## Descriptions of Major Course Assignments

### Attendance

Because this is an online course, your attendance is based on your online activity and participation. Your attendance will be recorded manually at the start of each class. If you join late, please email the instructor to ensure that your attendance was recorded. Because grades are based to a large degree on class attendance, if a student will be absent, it is expected that the student will let the instructor know in advance. In cases when students cannot let the instructor know in advance, it is expected that they will let the instructor know as soon as possible. Students who inform the instructor of the absence can submit a self-researched paper (1 page minimum, 2-page maximum, single spaced, 11 pt font, 1 inch margins) on the topic that was discussed within 3 calendar days of the missed class to receive credit for attendance and participation, for up to 2 absences. For absences in which the instructor was not informed and for absences in excess of 2, the points for missed classes cannot be made up.

**Academic integrity and collaboration:** You have to attend class to earn these points; no collaboration is allowed for this assignment.

### Active Participation

Students will be assessed on their active participation in the discussion by the degree to which they (1) ask meaningful questions of the speaker and (2) provide thoughtful contributions in the discussion sessions.

- **Ask meaningful questions** in lectures to show your understanding of the topic and further the discussion
- **Provide thoughtful contributions** to the journal club to demonstrate your understanding of the material and further the discussion
- Questions are to be submitted via chat during class. In lectures, the instructors will call on students; in discussion sessions, the lead will call on students. There may not be time to verbally share all questions but students will get credit for active participation as long as they have at least one in each class.

- If the student is unable to ask meaningful questions or make thoughtful contributions during class because the topic is not clearly understood or for any other reason, the student should follow up with the instructor to pursue other options for earning credit for active participation.

**Academic integrity and collaboration:** Points for this assignment are based on your contribution; no collaboration is allowed for this assignment.

## Reflection Papers

Five days after each discussion session, a one-page reflection must be turned in on CarmenCanvas. The one-page reflection should describe the knowledge gained from the lecture and discussion session and provide an individual reflection on how this knowledge may relate to the student's future career aspirations. A completed paper with content as noted will receive a 3. If a paper is submitted and a student does not receive credit, an explanation will be provided so that future submissions can be adapted.

**Academic integrity and collaboration:** Your written assignments, including discussion posts, should be your own original work. In formal assignments, you should follow an accepted style (MLA/APA/Chicago etc.) to cite the ideas and words of your research sources. You are encouraged to ask a trusted person to proofread your assignments before you turn them in but no one else should revise or rewrite your work.

## Lead a Discussion Session

For the discussion session you are assigned, you are expected to develop an outline for the discussion to engage students on all the important topics in the readings and lecture. You can prepare questions, talking points, bullets, slides – whatever will help you to facilitate the discussion of the topic. This should not only be questions for the speaker, but can include questions for the speaker that we did not have time to address in the lecture.

**Academic integrity and collaboration:** You may be assigned to co-lead a discussion session with another student, depending on the number of students in the class. In that case, both co-leads will receive the same grade. You are expected to collaborate for this assignment.

## Late assignments

Reflection papers are due by midnight Sunday after the discussion session. Late submissions may be accepted but need to be approved by the instructor.

## Grading Scale

Satisfactory/Unsatisfactory. The student will receive a satisfactory grade if 80 points or more have been earned during the semester.

## Faculty feedback and response time

I am providing the following list to give you an idea of my intended availability throughout the course. (Remember that you can call **614-688-HELP** at any time if you have a technical problem.)

- **Grading and feedback:** Since the class is graded satisfactory/unsatisfactory, and no partial credit will be given on the reflection papers, extensive feedback on reflection papers will not be regularly provided. As

noted above, if credit is not given on the paper due to incompleteness, that feedback will be provided to the student so adjustments can be made for future submissions.
